

Rover's Romphouse PlayCare & Boarding Agreement

In consideration for the services provided by Rover's Romphouse, I agree to the following:

1. I certify that my pet is in good health and has not been ill with any communicable condition in the last 30 days. To the extent my pet is a dog, I further certify that my dog has not injured or shown aggressive or threatening behavior towards any person or another dog. I understand that in agreeing to admit my pet for services, Rover's Romphouse and its staff have relied on my representations and certifications regarding my pet's health and behavior, together with all other information provided in this Agreement and any other supplemental documentation.
2. I understand and agree that I am fully responsible for any and all harm, damage, and/or injury caused by my pet, including injury to persons and other pets, as well as damage to bedding and property of Rover Romphouse and third parties. Damage to bedding does not include any potty or scratches in the Catnip Room.
3. Due to the nature of services being provided and the unpredictability of pets' behavior, especially in an interactive play setting, I hereby fully waive and release Rover's Romphouse, its employees, officers, volunteers, and agents, from liability of any kind or nature for any injury, including death, or damage to me, my pet or my property. I expressly assume the risk of any such injury, including death, and/or damage while I or my pet is on Rover Romphouse premises.
4. I authorize Rover's Romphouse, in its best judgment, to seek veterinary treatment for my pet in the event of an emergency, and I agree to pay any medical and/or veterinary expenses incurred as a result of illness or injury to, or caused by, my pet. Although I authorize Rover's Romphouse to seek emergency veterinary care for my pet, I understand that the decision is subjective and that in some instances, immediate veterinary care may not be possible. I hereby waive any claim against and will not hold Rover's Romphouse liable for failure to seek veterinary attention for my pet or for any negligent, unnecessary, substandard or other veterinary care actually given to my pet.
5. Rover's Romphouse reserves the right to refuse admittance to any dog and to terminate any service agreement at any time in its sole discretion. You agree if Rover's Romphouse, in its sole opinion, determines your pet can no longer stay at the facility, you will immediately arrange to pick up your pet.
6. I agree that the many benefits of dog socialization outweigh any risks. I am aware of and understand the risks, including possible injury, illness or trauma to my dog, and I specifically request a socialized environment for my dog while attending Rover's Romphouse.
7. I have received, read, understand, and agree to the payment terms, fees and polices as outlined in Rover's Romphouse PlayCare and Boarding General Information and Policies which can be found on our website and are fully incorporated herein by reference. Rover's Romphouse may charge my credit card on file for all outstanding fees and expenses owed by me. I understand that collection procedures may be initiated for non-payment and that I will be responsible for all associated expenses, including attorney fees and court costs.
8. I agree to indemnify and save harmless Rover's Romphouse, its employees, officers, volunteers, and agents from loss or damage of any kind incurred by any one of them by reason of my actions or omissions or my pet's action or behavior.
9. I warrant that I have the authority to represent all owners of the pet I am bringing to Rover's Romphouse in signing this Agreement.
